Prevention Worker, Primary & Secondary School – initial project May 14 to May 15 (Prevention Worker funded for a further year, September 15 to August 16): Positive feedback from participants re. the appropriateness & delivery of awareness sessions at school – 2,610 young people have benefited from Craven awareness sessions, approximately 50% primary & 50% secondary - 549 parents / carers / professionals have also received guidance - 9 referrals made for more intensive one to one support - 70% of sessions led to individuals approaching the Worker to ask for advice / guidance relating to specific issues covered during the course – A number of young people communicated that there is a lack of awareness & support given to them in relation to keeping safe personally, online & with	

their peers - There were concerns raised about the number of young children using social media without knowledge of their parents & / or outside of guidelines for age, leading to the conclusion that more advice is needed for adults who care for children. Intensive Individual Support Worker - February 15 to January 16: Working with young people up to the age of 21 who are either involved in or at risk of CSE - Local presence has enabled relationships to be built between social work teams, youth services, health professionals, police & other front line services. One to one work focuses on recovery from abuse endured, breaking the cycle of abuse, skills to understand what has happened & how to avoid similar situations — 8 referrals received of which one young person refused services.

Interim adult SARC solution (April 15-March 16) in place with CRG Medical Services (acquired Medacs' forensic healthcare division). Latest contract review meeting held 5th August – no operational issues, quality & performance standards being met or exceeded. Regional adult SARC solution tender launched 26th May, bidder event 15th June attended by 8 providers, tenders received 31st July, local & regional evaluation process 3rd-17th August, recommendation to RCB for approval second week of September. Paediatric SARC solution (April 15-March 16) Monday to Friday 9-5 solution negotiated with York Teaching Hospital NHS Foundation Trust, to commence October 15. Task & finish group set up with NHS England & regional force colleagues to address current gaps in paediatric services for acute victims out of hours, due to capacity issues within current paediatric forensic skills base. Arrangements now in place with St Mary's, Manchester to accept North Yorkshire
