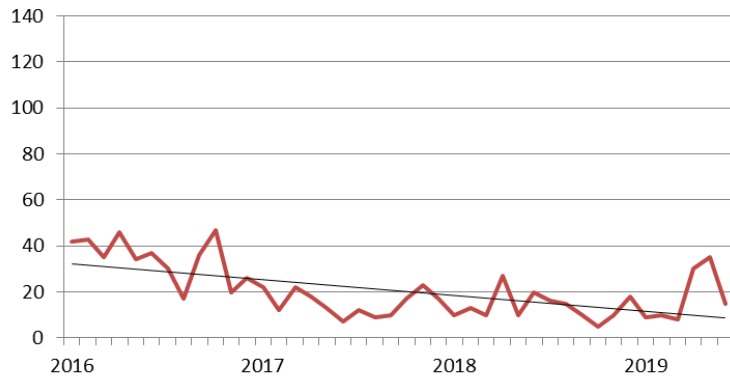

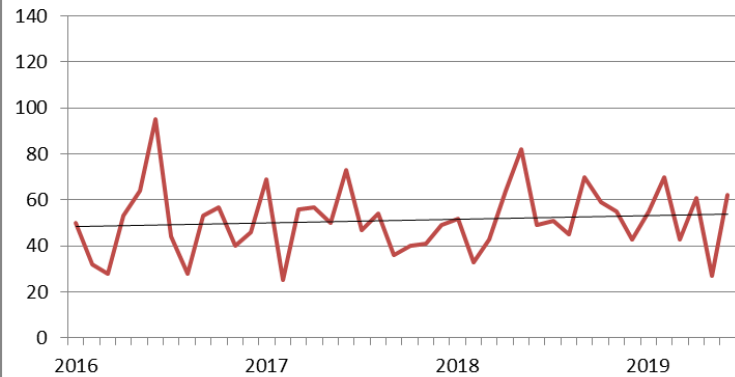

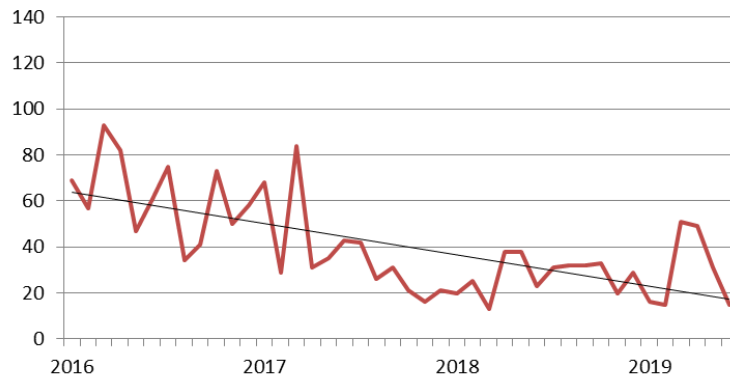

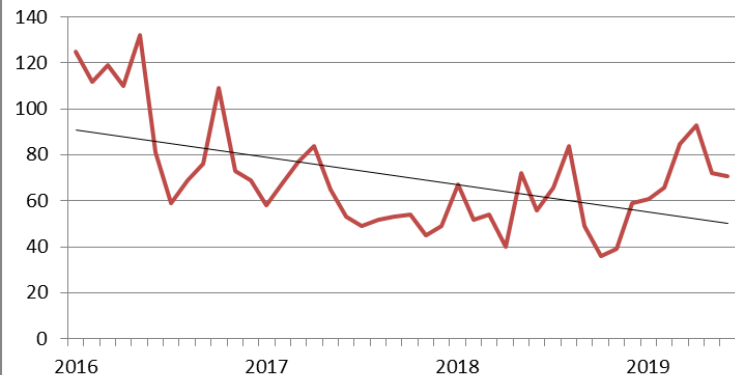

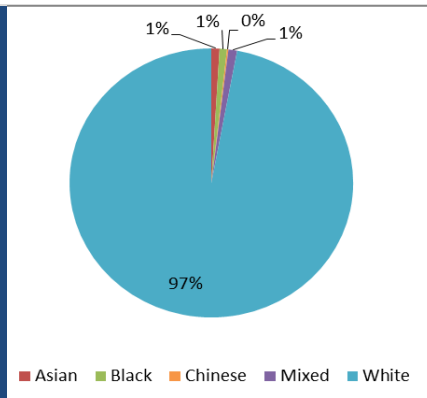

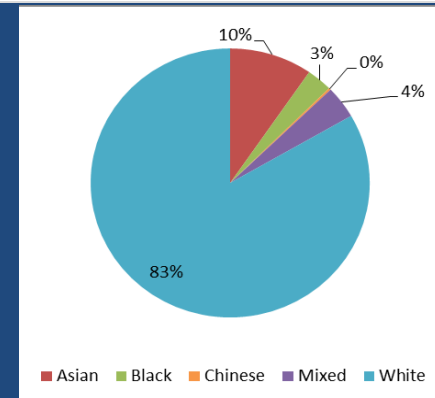
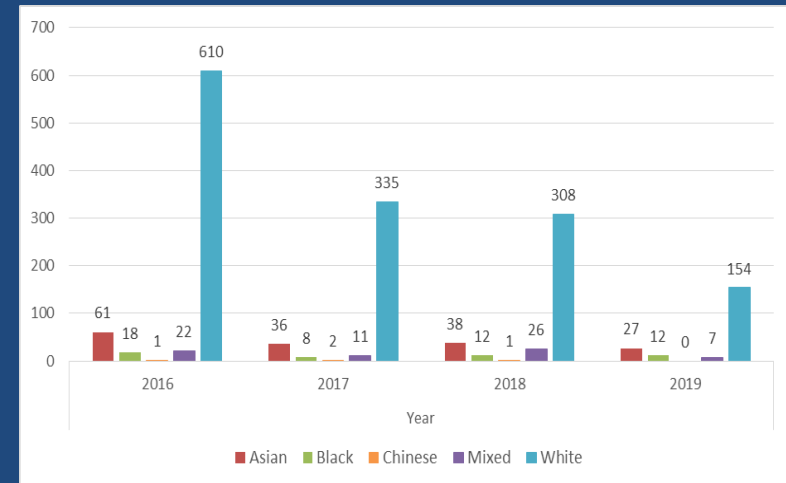
Stop and Search Data – Self-defined ethnicity by home address 2016 - 2019



NYP resident



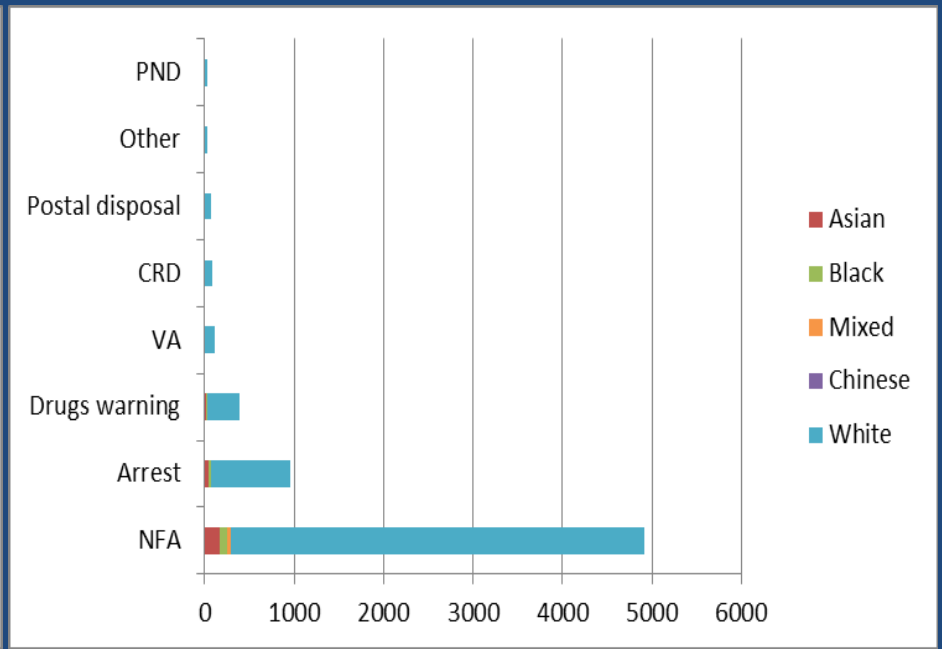
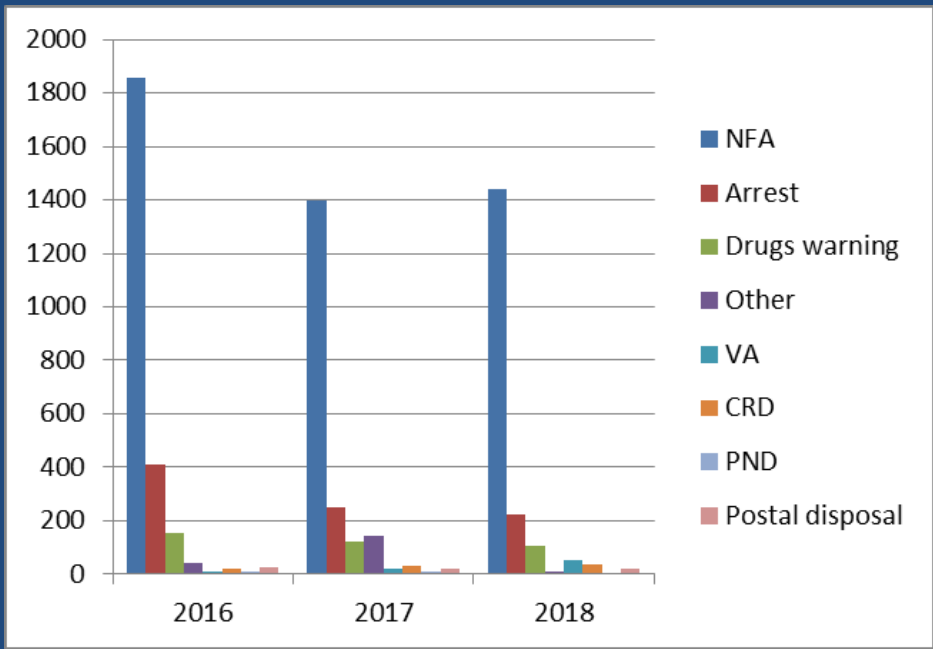
Non- NYP resident



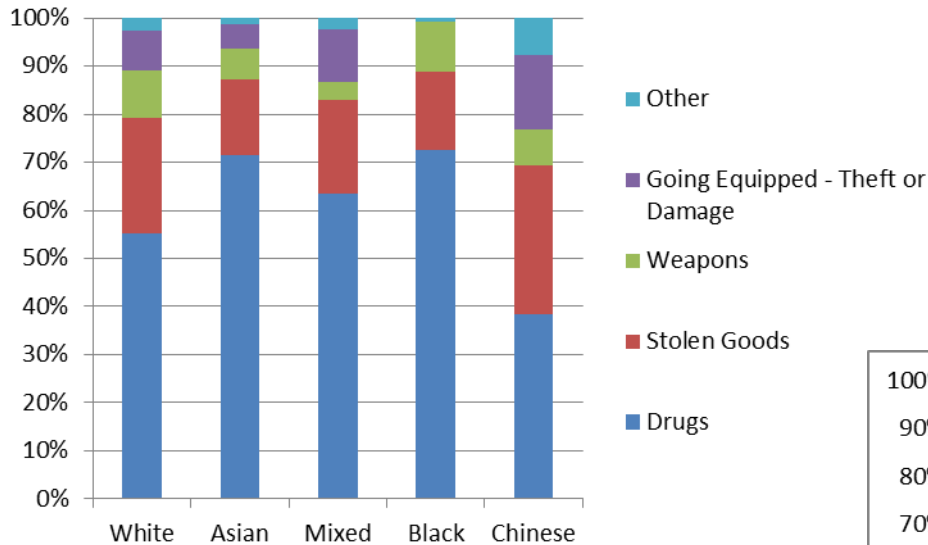
Stop and Search Data – Reasons



Stop and Search Data – Outcomes

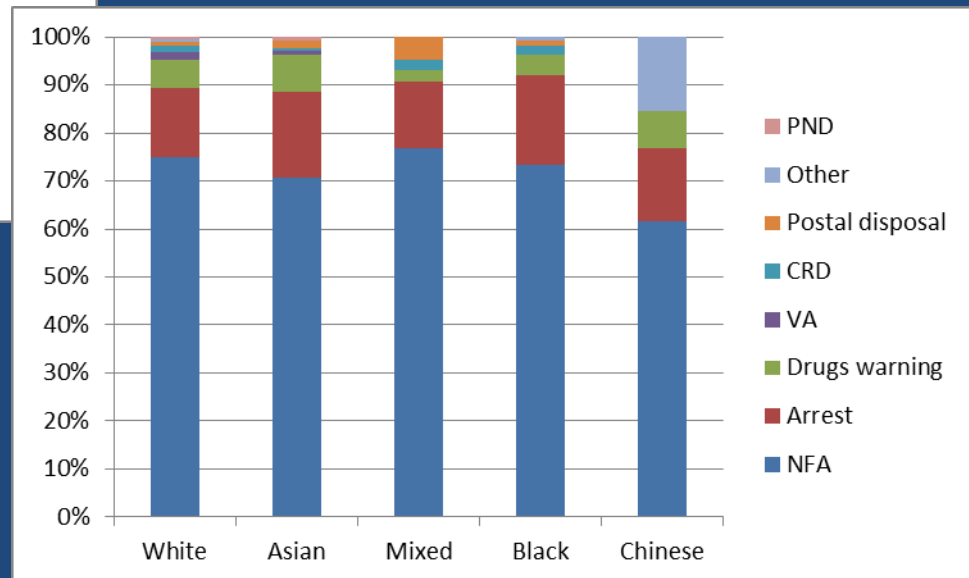


Stop and Search Data – Reasons and Outcomes by self-defined ethnicity as % of total
